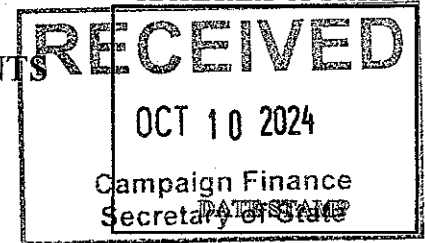


IMPORTANT
